

This text contains binding rules and conditions for competitors

WEDDING EXPO 2022: FREE WEDDING

(hereinafter referred to as the "Competition")

ORGANIZER OF THE COMPETITION

- The organizer of the competition is the company WEDNET s.r.o., Kováků 1811/12, 150 00 Prague 5, ID: 27206343 (hereinafter referred to as the "organizer").

DURATION AND LOCATION

- The competition takes place on the territory of the Czech Republic.
- The duration of the competition is set for the period from 14.10.2022 - 26.11.2022 - from the moment the competition is announced on the WEDDING EXPO 2022 website available at <http://www.svatebniexpo.cz/>, (hereinafter referred to as the "WEDDING EXPO website") , until 26.11.2022 at 4:00 p.m.

COMPETITION TERMS

- Only persons who have reached the age of 18 can participate in the competition.
- Only purchases of raffle tickets made between October 14th 2022 and November 26th 2022 until 16:00 on the portal <https://www.smsticket.cz/vstupenky/31225-svatebni-expo#vice-informaci> can compete. Subsequently, the registration for inclusion in the competition will be closed.
- The price of the competition ticket is CZK 100.
- The competition ticket is only valid together with a valid ticket to the wedding fair Wedding Expo on November 25-26, 2022. A separately purchased competition ticket is invalid.
- The number of purchased tickets per person is unlimited.
- The prize is not legally enforceable.
- The prize cannot be transferred to other persons.
- The prize cannot be redeemed in cash or other material compensation can be provided for it. Unclaimed winnings are forfeited to the organizer. The competitor has no legal claim to the prize. The result of the competition is final, without the possibility of appeal. Claiming the prize or participation in this competition through legal or judicial means is excluded.

WIN CONDITIONS

- The prize of the competition is the planning and realization of the event Free Wedding 2023 with a total value of CZK 230,000 (including VAT) including 23 wedding services.

- Prague Weddings reserves the right to select subcontractors for these services.
- The free wedding is calculated for a maximum of 23 wedding guests.
- A free wedding is a symbolic wedding. The official, legal ceremony is provided by the winner.
- The free wedding will be held at the Volcano Spa Hotel, K Sopce 839/30, 158 00 Prague 5 - Jinonice on a weekday in May 2023.
- The location and number of wedding participants can only be changed after agreement with the organizer. The winner of this decision bears additional costs with the above changes. Additional costs represent an increase in costs to all subcontractors, e.g. travel costs.
- The winner is given the option of extending the services at the winner's own expense.
- All changes must be made in writing and agreed upon by both parties.
- Signing the contract on the implementation of the Free Wedding 2023 and confirming acceptance of the conditions is a condition.

PROCESS OF THE COMPETITION AND SELECTION OF THE WINNER

- On November 26th, 2022 at 4:00 p.m., the organizer will draw a winning ticket live on the IG and FB social networks.
- The winner will be informed about the prize and the next procedure for handing over the prize by phone and email no later than 7 working days after the end of the competition.
- A winner who does not claim the prize or refuses it loses the right to win in the future.
- The organizer is not responsible for the fact that the winner did not claim or that the winner did not respond to the text message sent with information about the win. The organizer is also not responsible for other reasons why the winner did not read the message from the organizer or did not contact the organizer, unless these reasons lie on the part of the organizer.
- The organizer undertakes in relation to the winner to send a notification of the win by e-mail at the same time. If the attempt is unsuccessful and/or the winner does not contact the organizer within the period specified in the email sent by the organizer as notification of the win, the organizer is entitled to decide to forfeit the prize.
- If the winner does not claim or refuses the prize, the organizer will draw a new winner.

COPYRIGHT AND PROMOTION OF THE COMPETITION

- The organizer reserves the right to promote the announcement of the competition and the realization of the prize on its profile on social networks and websites. The winner agrees to the use of photos and entries for these purposes.
- The organizer publishes the progress of the prize realization on the Prague Weddings profile, on the Wedding Expo profile (on FB, IG social networks), and on the social networks of partners (subcontractors) participating in the competition. The winner grants the organizer a non-

exclusive, transferable, further licensable, time and territorially unlimited license to use such photo in all known ways of use, in the original or other processed or otherwise changed form, separately or in a file, or in connection with another work or elements. The license is granted free of charge.

- The winner expresses his consent to the use of his likeness / likeness, if it is captured in a photograph, free of charge, unlimited in time, territory and quantity, within the scope of the license according to the previous paragraph. The competitor confirms that the same consent to the use of his likeness and consent to the processing of personal data was also granted by the other persons captured in the photograph.

PROCESSING AND PROTECTION OF PERSONAL DATA

- By purchasing a raffle ticket, the competitor gives consent to the processing of personal data.
- The organizer hereby informs the competitors and winners that their personal data will be processed in the scope of first name, surname, e-mail address and telephone number, for the duration of the competition and 3 years after its end, for the purpose of (1) participating in competition, (2) verification of his valid participation in the competition, (3) informing about the progress of the competition, (4) handing over the prize, (5) handing over contacts to the competition partners as subcontractors of individual parts of the prize and (6) realization of the planning of the Free Weddings prize and associated with it promotion.
- The administrator of the competitor's personal data is the organizer, who will process personal data in accordance with the relevant legal regulations for the protection of personal data. The processing of personal data can also be carried out by other processors, namely competition partners, i.e. subcontractors of prize services.

OTHER JOINT ARRANGEMENTS

- The organizer is not otherwise obligated to the competitors and they are not entitled to any other benefits from the organizer than those stated in these rules.
- By participating in the competition, each competitor expresses his agreement with these rules and undertakes to comply with them and not to violate the legal order of the Czech Republic or the legitimate interests of the organizer.
